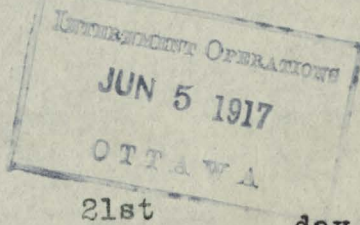

 Police Officer to the point of work.



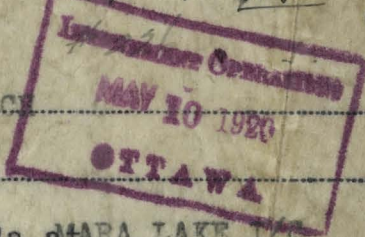
